1. ENTRY

Talent Contest Entry Forms may be picked up at the Fort Bend County Fair Office or online at www.fbcfa.org.

All entries must be received by the Fort Bend County Fair by 5:00 p.m. on Friday, August 26, 2011. Entries may be delivered to 4310 Hwy. 36 South, Rosenberg, Texas 77471 or mailed to P.O. Box 428, Rosenberg, Texas 77471. THERE WILL BE NO EXCEPTIONS TO THIS RULE.

No telephone entries will be accepted.

ENTRY FEE MUST ACCOMPANY ENTRY FORM

- Elementary Division - \$20.00 Entry Fee
- Junior, Intermediate & Senior Divisions - \$30 Entry Fee
- Adult Division - \$50 Entry Fee

2. CONTESTANTS

No one will be allowed to compete in more than one category.

All contestants must attend all meetings schedule by the Director in Charge of the Talent Contest.

Costumes worn by the contestants must not be offensive, disrespectful or suggestive. No props will be allowed. No offensive language or music will be allowed. If not adhered to, production will be stopped and contestant will be disqualified by the Judges, Chairman or Director.

The Talent Show is not limited to solo only singing acts or instrumental acts. Anyone may enter. Musical instrument or an accompanist is allowed.

Depending on the number of entries, a preliminary contest may be scheduled and if so, you will notified at least two weeks in advance.

Registration is open to all counties.

Each contestant will receive one complimentary pass only for the day of the competition. Parents, guardians or anyone else accompanying contestant must purchase tickets at the gate.

3. CONTEST RULES

Each act is limited to five (5) minutes.

Lip-synching is not allowed. All judges' decisions are final.

All contestants must be at the Brazos Stage by 11:00 am on the day of the competition to receive entry numbers.

ALL ENTRIES WILL BE JUDGED ON THE BASIS OF TALENT, SHOWMANSHIP, AUDIENCE RAPPORT AND STAGE PRESENCE. THE DECISIONS OF THE JUDGES ARE FINAL. (THESE DECISIONS ARE SOLELY THE OPTION OF THE JUDGES AND DO NOT REPRESENT THE VIEWS OF THE FORT BEND COUNTY FAIR BOARD OF DIRECTORS OR COMMITTEE. GRIEVANCES MUST BE IN WRITING AND SENT TO THE FORT BEND COUNTY FAIR WITHIN A TWO WEEK PERIOD FOLLOWING THE COMPETITION. ONLY WRITTEN COMPLAINTS SHALL BE CONSIDERED). ALL DECISIONS MADE BY THE FORT BEND COUNTY FAIR BOARD OF DIRECTORS ARE FINAL.

- ELEMENTARY AGE 4 – 6 YEARS
- JUNIOR AGE 7 – 10 YEARS
- INTERMEDIATE AGE 11 – 14 YEARS
- SENIOR AGE 15 – 18 YEARS
- ADULT AGE 19 YEARS & OLDER

(Age will be determined as of the date of the competition)

5. **EQUIPMENT**

Sound System will be provided.

Singers using CD accompaniment must provide it with marked tracks. No tapes will be allowed.
